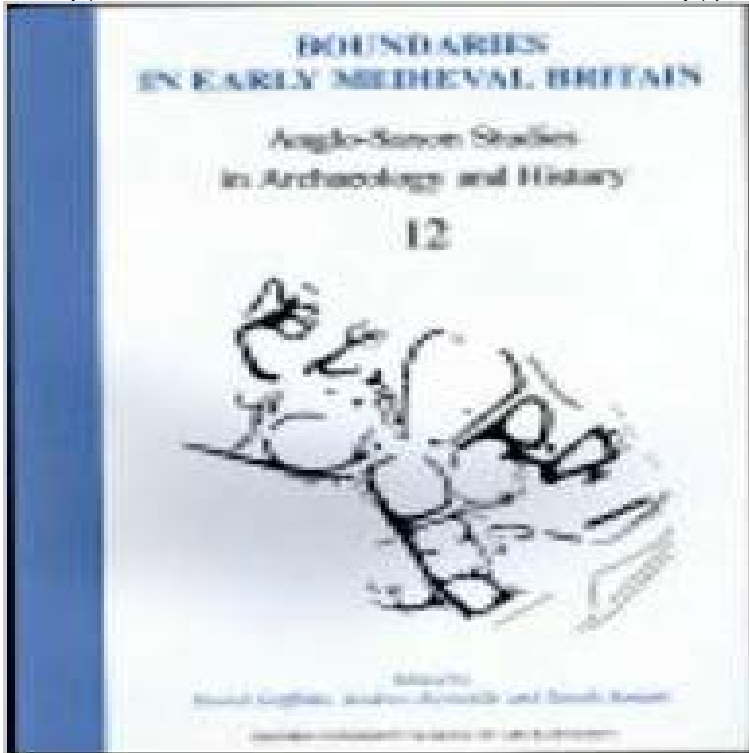


Anglo-Saxon Studies in Archaeology and History 12 (None) (v. 12)
